Post of Assistant Site Manager

The postholder will support and assist the Site Manager in ensuring the school's site, buildings and facilities are maintained to the highest possible standard, in order to facilitate the full and effective use of the school by all staff, students and visitors.

The postholder in collaboration with the Site Manager will have the following responsibilities:

Duties

- To maintain a clean, safe, secure and pleasant environment.
- To deliver effective, efficient and economic services wherever practicable.
- To line manage the Site Staff.
- To actively promote the school premises to the outside community.

School Site

- 1. Management of the school site staff
 - Task lists for individual members of the site team (including the postholder) are linked to the school calendar of activities and events.
 - Priorities are agreed with the Site team on a weekly basis.
 - Training needs are identified and planned.
 - Performance Management reviews are carried out and targets set in a timely fashion.
- 2. To be proactive in monitoring the cleanliness of the school site, ensuring the site is kept clean and tidy at all times
 - Waste bins emptied regularly (no bins overflowing).
 - Litter cleared regularly (minimum twice daily).
 - All areas swept regularly.
 - All areas within the school are free from litter and that all drains and gullies are free flowing and clean.
 - The school premises are inspected and prepared for after school activities e.g. Parent Evenings.
- 3. To manage the day to day maintenance operations of the school
 - Maintenance/service contracts are in place and current.
 - Caretaking equipment is in a safe and working condition and any appropriate repairs are carried out in a timely fashion.
 - Heating plant is maintained at the required temperatures.
 - An adequate supply of hot water is available.
 - Inspections of ancillary equipment are carried out on a regular basis e.g. pumps, batteries etc
 - Ensure that the school receives appropriate certification for equipment and that certification is safely stored.
- 4. To assume initial responsibility for the resolution of all site related issues
 - Assess whether work can be carried out by the site team (including the Post Holder) e.g. minor plumbing, glazing, carpentry, redecoration etc.
 - Assess the priority of the work.
 - Ensure that all emergency maintenance is carried out promptly.
 - Continually review the skills and training requirements of the site team to ensure that work is carried out by site staff wherever possible.
- 5. To ensure that the site is secure at all times
 - Ensure that the site is unlocked in preparation of the school day and locked and checked at the end of each day.
 - Provide access to the premises and classrooms (where possible) in the event of snow, minor flooding or other emergency situations.

- Carry out emergency repairs to secure the premises following a break-in.
- Manage the contractor activity on the school site, on a daily basis.
- Prevent unauthorised access to the school site.
 (Note: in fulfilling this responsibility all employees are expected to work within established school procedures and the Code of Practice No. 32(S) Managing Violence in Schools).
- 6. To be actively involved in all building projects within the school, liaising with consultants and contractors as necessary.

Service Contracts

- 1. To assist in the set up and management of all Service Contracts:
 - o Electrical / Mechanical e.g. heating, air conditioning
 - Water / Pool equipment
 - Waste Disposal
 - o Fire Equipment
 - o Alarms
 - o Pest Control
 - o Chimneys / Kilns / Lightening conductor
- Make recommendations regarding the improvement/development of the school site and services.
- 3. Make recommendations regarding cost saving opportunities across the school site.
- 4. To identify and prioritise the maintenance requirements of the school and agree a programme for maintenance, servicing and redecoration.
- 5. Maintain an inventory of caretaker equipment and carry out an annual check against the inventory.

Health & Safety / Regulatory

- 1. Maintain a knowledge of current standards and regulations that may be applicable to site management and maintenance e.g. Portable Appliance Testing (P.A.T.).
- 2. Maintain a knowledge of current Health & Safety codes of practice in relation to premises and caretaking and report any issues to the Health & Safety officer.
 - Maintain an up to date Asbestos Management Plan and Register. Ensure all contractors are made aware of the Asbestos register and sign it prior to commencing work on site.
 - Organise regular monitoring of all areas containing asbestos in line with the A.M.P.
- 3. Ensure all safety and service inspections are carried out within the required timeframes:
 - Fire Risk Assessment and related safety checks.
 - Legionella Testing
 - E.I.C.R. Certification
 - C.O.S.H.H. Regulations are followed.
 - P.A.T. Testing
 - Risk Assessments are relevant and kept up to date e.g. Working at Height, Manual Handing, Lone Working etc.
- 4. Advice on the closure of the school in adverse weather conditions.
- 5. In the event of civic emergency, make the school site available, as designated by the local authority.

The postholder will be expected to undertake any other reasonable task or responsibility, which may be required under the direction of the headteacher, which is not covered by the above.

How to make an application;

Please complete the application form in black ink or typescript. This application form and process has been designed to provide the range of information necessary for a fair and consistent approach to recruitment. We strongly advise that you carefully read all available information for this job before you start completing the form. Included in this pack are a full job description and a person specification, detailing the skills, qualifications and experience that are required for this job.

You must demonstrate in your application how you are able to fulfil the requirements of the person specification and job description for the post, as this will form the basis on which decisions are made on selection for interview.

Work permit/Evidence of permission to work in the UK (front page)

Please let us know if you are an overseas national who requires a work permit to work in the UK. You should check your immigration status, if applicable, before answering this question.

Prior to commencing employment with the school, <u>all</u> members of staff will be required to produce documentary evidence of permission to work in the United Kingdom. Candidates who are asked to complete the DBS form will also be asked to show evidence of identity eg birth certificate/passport/driving licence etc. Any information disclosed will be kept in strict confidence and used only in consideration of your suitability for the job for which you are applying. If you fail to disclose any convictions, then your employment could be subject to dismissal or disciplinary action by the school.

Recruitment and Selection Policy Statement

- The Governing Board is committed to:
 - safeguarding and promoting the welfare and safety, and the spiritual, moral, social and cultural development, of children and young people;
 - promoting equality of opportunity and community cohesion where the diversity of different backgrounds and circumstances is appreciated and positively valued;
- promoting the fundamental British values of democracy, the rule of law, individual liberty and mutual respect and tolerance for those with different faiths and beliefs and expects all staff, volunteers and other workers to share this commitment. It is recognised that this can only be achieved through sound procedures, good inter-agency co-operation and the recruitment and retention of competent, motivated employees who are suited to, and fulfilled in the roles they undertake.
- 2. The Governing Board recognises the value of, and seeks to achieve a diverse workforce which includes people from different backgrounds, with different skills and abilities. We are committed to ensuring that the recruitment and selection of all is conducted in a manner that is systematic, efficient, effective and promotes equality of opportunity. Selection will be on the basis of merit and ability, assessed against the qualifications, skills and competencies required to do the job. We will uphold obligations under law and national collective agreements to not discriminate against applicants for employment on the grounds of the protected characteristics of age, sex, sexual orientation, marriage or civil partnership, pregnancy, gender reassignment, disability or health, race (which includes colour, nationality and ethnic origin), religion or belief.
- 3. We will implement robust recruitment procedures and checks for appointing staff and volunteers to ensure that reasonable steps are taken not to appoint a person who is unsuitable to work with children, or who is disqualified from working with children, or does not have the suitable skills and experience for the role.
- 4. We will ensure that the terms of any contract with a contractor or agency requires them to adopt and implement measures described in this procedure. We will monitor the compliance with these measures and require evidence that relevant checks have been undertaken for all workers deployed.
- 5. The following pre-employment checks will be required where applicable to the role and settling:
 - receipt of satisfactory references*
 - verification of identity
 - a satisfactory DBS disclosure if undertaking Regulated Activity
 - verification that you are not on the DBS Children's barred list and therefore not barred from working with Children
 - verification that you are not prohibited from teaching
 - verification of medical fitness
 - verification of qualifications
 - verification of professional status where required e.g. QTS status
 - the production of evidence of the right to work in the UK
 - verification of successful completion of/exemption from statutory induction period
 - verification that you are not subject to any s128 directions preventing you from holding a management position within a school
 - a declaration that you are not disqualified from working with children by virtue of the Childcare (Disqualification) Regulations 2018 or that you have provided a disqualification waiver from Ofsted

NB It is illegal for anyone who is barred from working with children to apply for, or undertake Regulated Activity.

*In exceptional circumstances, where you have good reason not to want your referees to be contacted prior to interview, you should set out your reasons with your application form. Where it is agreed to defer, referees will be contacted immediately after interview before an offer of employment is made.

- 6. We will keep and maintain a single central record of recruitment and vetting checks, in line with the current DfE requirements.
- 7. All posts/voluntary roles that give substantial unsupervised access to children and young people are exempt from the Rehabilitation of Offenders Act 1974 and therefore all applicants will be required to declare spent and unspent convictions, cautions and bind-overs (save for those offences that are subject to filtering by the Police).

Applicants will be required to sign a DBS consent form giving consent for the DBS certificate to be copied and shared (within strict guidelines) for the purposes of considering suitability for employment and consent for an online status check to be carried out in the event that the applicant subscribes to the DBS update service.

The Governing Board is committed to ensuring that people who have convictions / cautions / reprimands on their record are treated fairly and given every opportunity to establish their suitability for positions. Having a criminal record will not necessarily be a bar to obtaining a position, except in the case of school settings covered by the Childcare (Disqualification) Regulations 2018 where certain convictions, cautions or warnings will mean an individual is disqualified from working in that setting and will prohibit employment at the school (unless a waiver can be obtained from Ofsted).

Positive disclosures will be managed on a case by case basis taking into account the nature, seriousness and relevance to the role. The following factors will be considered in each case:

- The seriousness/level of the disclosed information eg was it a caution or a conviction.
- How long ago did the incident(s) occur?
- Whether it was a one-off incident or part of a repeat history/pattern.
- The circumstances of the offence(s) being committed and any changes in the applicant's personal circumstances since then.
- The country where the offence/caution occurred.
- Whether the individual shows or has shown genuine remorse.
- If the offences were self-disclosed on the SD2 form or not (non-disclosure could, in itself, result in non-confirmation of employment on the grounds of trust, honesty and openness).

When making a recruitment decision The Governing Board will disregard any filtered convictions/cautions/reprimands which were disclosed in error.

A previously issued Disclosure and Barring Service Certificate will only be accepted in certain restricted circumstances or where you subscribe to the DBS update service and the appropriate online status checks have been satisfactory.

The Disclosure and Barring Service has published a Code of Practice and accompanying explanatory guide. This Governing Board is committed to ensuring that it meets the requirements of the Disclosure and Barring Service in relation to the processing, handling and security of Disclosure information.
