<b>Purpose:</b>	<p>To implement and deliver an appropriately broad, balanced, relevant and differentiated curriculum for students and to support a designated curriculum area as appropriate.</p> <p>To monitor and support the overall progress and development of students as a teacher/ Form Tutor</p> <p>To facilitate and encourage a learning experience which provides students with the opportunity to achieve their individual potential.</p> <p>To contribute to raising standards of student attainment.</p> <p>To share and support the school's responsibility to provide and monitor opportunities for personal and academic growth.</p>

<b>Operational/ Strategic Planning</b>	<p>To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the subject area.</p> <p>To contribute to the subject's development plan and its implementation.</p> <p>To plan and prepare courses and lessons.</p> <p>To contribute to the whole school's planning activities.</p>
<b>Curriculum Provision:</b>	To assist the subject leader in ensuring that the curriculum area provides a range of teaching which complements the school's strategic objectives.
<b>Curriculum Development:</b>	To assist in the process of curriculum development and change so as to ensure the continued relevance to the needs of students, examining and awarding bodies and the school's strategic objectives.
<b><u>Staffing</u></b>  <b>Staff Development:</b>  <b>Recruitment/ Deployment of Staff</b>	<p>To take part in the school's staff development programme by participating in arrangements for further training and professional development. <b>Quality Assurance:</b>	<p>To help to implement school quality procedures and to adhere to those.</p> <p>To contribute to the process of monitoring and evaluation of the curriculum area/department in line with agreed school procedures, including evaluation against quality standards and performance criteria. To seek/implement modification and improvement where required.</p> <p>To review regularly methods of teaching and programmes of work.</p> <p>To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions.</p>
<b>Management Information:</b>	<p>To maintain appropriate records and to provide relevant accurate and upto-date information for CMIS, registers, etc.</p> <p>To complete the relevant documentation to assist in the tracking of students.</p> <p>To track student progress and use information to inform teaching and learning.</p>



<b>Communications:</b>	<p>To communicate effectively with the parents of students as appropriate. Where appropriate, to communicate and co-operate with persons or bodies outside the school.</p> <p>To follow agreed policies for communications in the school.</p>
<b>Marketing and Liaison:</b>	<p>To take part in marketing and liaison activities such as Open Evenings, Parents Evenings, and liaison events with other/partner schools.</p> <p>To contribute to the development of effective subject links with external agencies.</p>
<b>Management of Resources:</b>	<p>To contribute to the process of the ordering and allocation of equipment and materials.</p> <p>To assist the Subject Leader to identify resource needs and to contribute to the efficient/effective use of physical resources and the learning environment.</p> <p>To co-operate with other staff to ensure a sharing and effective usage of resources to the benefit of the School, department and the students.</p>
<b>Pastoral System:</b>	<p>To be a Form Tutor to an assigned group of students.</p> <p>To promote the general progress and well-being of individual students and of the Form Tutor Group as a whole.</p> <p>To liaise with a Pastoral Leader to ensure the implementation of the school's Pastoral System.</p> <p>To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life</p> <p>To evaluate and monitor the progress of students and keep up-to-date student records as may be required.</p> <p>To contribute to the preparation of Action Plans and progress files and other reports.</p> <p>To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved.</p> <p>To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff</p> <p>To contribute to PSHCE and citizenship and enterprise according to school policy</p> <p>To apply the Behaviour management systems so that effective learning can take place for all students.</p>
<b>Teaching:</b>	<p>To teach, students according to their educational needs, including the setting and marking of work to be carried out by the student in school and elsewhere.</p> <p>To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as are required.</p> <p>To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.</p> <p>To ensure that ICT, Literacy, Numeracy and school subject specialism are reflected in the teaching/learning experience of students</p> <p>To undertake a designated programme of teaching.</p> <p>To ensure a high quality learning experience for students which meets internal and external quality standards.</p> <p>To prepare and update subject materials.</p> <p>To use a variety of delivery methods which will stimulate learning appropriate to student needs and demands of the syllabus.</p>

	To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards
