Duties	<ul> <li>To receive from the officer in charge a briefing relevant to the previous day</li> <li>To check all children at advised intervals, unless otherwise instructed or the need arises.</li> <li>To change and wash/shower children who are wet or dirty unless otherwise instructed.</li> <li>To offer basic medical supervision under the instruction of the person in charge for the evening and to monitor pupils known to be unwell. Also to alert the member of staff undertaking sleeping-in duty of any child who becomes unwell in the night.</li> <li>To take appropriate action to ensure the health, safety and security of all individuals and their environments.</li> <li>To ensure that all pupils remain in their allocated beds.</li> <li>To be aware of emergency procedures, e.g. fire drills, and as the most alert person during the night, to telephone the Fire Brigade in case of fire.</li> <li>To be aware of and implement procedures for dealing with disturbances, intruders or inappropriate activity.</li> <li>To maintain a daily log which records any instances of inappropriate activity or disturbances or medical problems.</li> <li>In order to remain awake and vigilant all night to perform such additional duties that are in keeping with the nature of the post which shall be determined by the Head of Residnetial or the Headteacher or his or her representative on duty. First priority should be given to the security and</li> </ul>		

protection of pupils.

- To liaise with day staff regarding individual pupils, and ensure adequate hand-over information is given.
- Completion of paperwork, update photos, displays, risk assessments and placement plans.
- Carry out light household duties e.g. washing, ironing, cleaning fridges and tidyng.
- To assist the day staff during hand-over period.
- To use whichever form of communication that is being used by the pupils in the residential unit.
- To contribute to the upkeep of the building and report the need for repairs.
- Attendance at staff meetings.
- To attend residential holidays when needed.
- To undertake driving duties as required.
- To attend required training courses, and any other appropriate courses, e.g. NVQ in Integrated Care Level 2 or 3.
- To attend regular supervision meetings.
- To work within the equal opportunities policy.
- To carry out other duties at the request of the Officer-in Charge.
- This job description may change with the needs of the school and of the pupils. The job description will only change after consultation and discussions between the Governors, the Headteacher and the Postholder.
- This job description is neither exclusive nor exhaustive.
