

Job Outline – Graduate Teaching Assistant with Maths Specialty

Responsible to:	Assistant Headteacher
Salary Grade:	Scale 3
Full time/Part time:	32.5 hours per week (9am–4pm), 39 weeks per year (38 weeks term time plus 1 week non pupil days)

Job Purpose

To provide directed classroom support within the Maths faculty and across the school where numeracy support is needed.

- > Promote the wider aspirations and values of the school.
- Recognise the importance of confidentiality and uphold the requirements of the new GDPR legislation.
- To be an effective communicator with all stakeholders, visitors and external professional colleagues as required.
- To be fully aware of the particular difficulties of individual pupils by referring to records and discussion with SENDCo and/or subject leaders.
- To assist in the preparation of teaching resources for subject areas, in particular to assist with preparation of materials to the needs of individuals or groups of children.
- To undertake intervention work on a 1:1 or small group basis
- To undertake mentoring on a 1:1 or small group basis





General
