### Job Purpose

To provide effective and efficient clerical and welfare support to the school

### Duties

#### Welfare

- To administer first aid to pupils as required, in keeping with the school's policy, and order first aid supplies as necessary
- To have an oversight of all first aid matters relating to sick/injured children.
- To liaise with parents regarding pupils' sickness/injury.
- To complete first aid records.
- To assist with visits of nurse, dentist etc
- To assist with the general welfare of pupils
- To organise first aid training for staff
- To maintain pupils' medical records in Horizons

#### Reception

- To be the first point of contact for both telephone and face to face enquiries and take messages where appropriate
- To ensure school security arrangements are always complied with, including the issue of visitor's badges and signing of the visitor's book
- To accept and sign for deliveries as appropriate
- To provide hospitality for visitors to the school

#### Clerical

- To undertake filing, photocopying and reprographic work as required, including the basic maintenance of the photocopier
- Sending of outgoing post and sorting incoming post
- To be responsible for checking and responding to emails on the school admin account
- To provide general clerical support as required
- To assist with the monitoring and maintenance of stock
- To assist with the medical administration of school visits in liaison with the teaching staff/office manager
- To undertake routine data input and typing
- To assist with lost property

### General

- To participate in the performance and development review process, taking personal responsibility for identification of learning, development and training opportunities in discussion with line manager
- To comply with individual responsibilities in accordance with the role, for health and safety in the workplace
